Dependency on PayGlobal 4.53.0

This version of the MYOB PayGlobal Employee Self Service (ESS) requires a minimum version 4.53.0 of PayGlobal.

DO NOT UPGRADE TO ESS 5.4.7.1 UNTIL PAYGLOBAL HAS BEEN UPGRADED TO AT LEAST 4.53.0

.Net Framework 4.7.2 Update

For Self-Service (web site and workflow engine) the .Net Framework version has been updated to 4.7.2. For you to use ESS 5.4.7.1 or later you will need to ensure that your Web server and Workflow engine server both have .Net 4.7.2 installed at a minimum.

Enhancements - All Countries

Workflow Activity - Actionable Employee Notes

It is now possible for Workflow Processes to add actionable employee/payroll notes via the new "Insert actionable employee note" activity from the Business activities section. Users will be able to specify the Source and Severity of the Note as well as indicate if further action is needed to address the note. The original "Insert employee note" activity will continue to work as is and will leave these new values empty.

Single Sign On (SSO) – Additional Logging

Additional logging has been added when employees try to authenticate using Single Sign On (SSO). This will help to trouble-shoot any authentication issues.

Leave Balance Conversion and Forced Compliance for Leave

A bug has been fixed where the conversion of leave balances between different units (hours/days/weeks) was not correctly assigning the new unit to the converted balance. This bug led to an issue where leave could be applied for despite the available balance being exceeded by the request and forced compliance validation being enabled.
