Workforce Management Employee Notes when Pending Update Status Changed

When changing the employee's "Has pending update" status (Integration tab of Employee form) to No, the user has the option to have all remaining unactioned Workforce Management employee notes automatically actioned.

If an employee is enabled for Workforce Management, certain employee fields are now disabled from being edited in PayGlobal. The information in these fields is sourced from workforce management and can be edited there.

2022-23 Tax and payroll compliance changes

ACC Earners' Levy Rate and Thresholds

The ACC earner's levy rate increases from \$1.39 to \$1.46 per \$100 of liable earnings. The ACC maximum liable earnings has also increased from \$130,911 to \$136,544. Changes are effective from 1 April 2022.

PAYE Rates, Thresholds, Tax Codes and Calculations

There are no changes for 2022/2023

Student Loan Repayment Rates and Threshold

The following Student Loan threshold values apply from 1 April 2022:

Frequency	2022 – 2023 Tax Year
Annual threshold	\$21,268
Weekly pay period (Threshold divided by 52)	\$409
Fortnightly pay period (Threshold divided by 26)	\$818
Four-weekly pay period (Threshold divided by 13)	\$1,636
Monthly pay period (Threshold divided by 12)	\$1,772.33

The standard student loan repayment rate remains at 12%.



Kiwi Saver

There are no changes for 2022/2023

Minimum Wage

Minimum hourly rates effective from 1 April 2022 are:

- Adults = \$21.20
- Starting and Training = \$16.96

Public Holidays

Observing Matariki starts this year - 24 June 2022. The date will vary each year.

KiwiSaver validation improvement

When processing the pay, if an employee is found to have an **inactive** superfund with a KiwiSaver state of 'In' or 'Holiday'. The pay will FAIL and give the following message:

"The employee needs to have a current active superfund given the employee has a KiwiSaver state of 'In' or 'Holiday'. Please fix."

Enhancements – Australia

This section describes Australia-specific software enhancements in this release version.

Single Touch Payroll

STP Phase 2 - Status update

PayGlobal is currently in the process of becoming an ATO approved STP Phase 2 (v4) digital service provider.

In the meantime, your organisation can continue to send payroll data via STP using the existing STP 2018 (v3) services. This possible because your organisation is covered by the MYOB deferral obtained for all MYOB products. The MYOB deferral date enables your organisation to continue using the STP 2018 (v3) services until 1 September 2022.

We expect our next release (v4.62) is expected to be the version where you can enable the STP 2020 (v4) services. This will be released as soon as we receive ATO approval.

STP Phase 2 - Readiness

If you have not done so already, we recommend completing all STP v4 preparation tasks as soon as possible to reduce the workload once v4.62 is available.

It is expected that most of our Australian customers have already upgraded to v4.59.0.0 and have completed all tasks required to prepare for switching on the STP 2020 (v4) services.

- For those that are upgrading from a version older than v4.59.0.0 you <u>must</u> complete all STP v4 preparation tasks before turning on STP v4. Please refer to the following documents:

 - o MYOB PayGlobal STP Phase 2 Transition Manual

IMPORTANT: Changing your allowance/deduction record configuration may impact Award and/or Payroll Rules. We recommend engaging with Professional Services for assistance.

- For those upgrading from v4.59.0.0 an additional preparation task needs to be completed in respect of reporting Salary sacrifice amounts. Please refer to the following documents:

- For those upgrading from v4.60.0.0 there are no additional preparation tasks.



Changes in v4.61 for STP

This version contains the following quality/technical improvements" specific to STP:

Internal Company ATO Branch Numbers can only contain numeric characters The ATO branch number can only be up to a 3-digit numeric value e.g., 001, 002, etc. A branch number of 0 is also not permitted.

These checks will be made on entering/updating the ATO branch number for an internal company.

Date effective "Employment Basic Code"

To derive the correct "Employment Basis Code" from historical pay data the following items were added to the **EmployeeHistory** table:

These fields will be set to NULL on upgrade and will only be populated on closing a pay.

If there is a need to populate the historical pays (i.e. if you are planning to turn on STP v4 partway through a tax year), you will need to engage with Professional Services to assist in that process.



Dependent Children UI validation

Upon saving changes to the "Do you have dependent children?" field on the Employee record, Medicare tab; the system now validates the setting with the related field "Number of dependent children

- If "Do you have dependent children?" is set to yes, then "Number of dependent children" must be greater than '0' (zero)
- If "Number of dependent children" is set to '0', then "Do you have dependent children?" must be set to **no**.

STP Manager Tool improvements

New submission date filters

The submission date filter in the STP Manager has been extended to allow custom date ranges, as well as selecting previous and current tax years.

Custom date range filter values do not get saved between sessions.

Insufficient Precision When Converting Annual Leave Balances

Details

When an annual leave table is converted from one set of units to another in the Annual Leave Table form, at times there was insufficient precision when carrying out the conversion. For example, when converting a leave balance of 128 hours to weeks, there was an imprecision of .01 week for an employee with a profile of 40 hours.

Resolution:

PayGlobal now calculates the conversion with a higher precision, avoiding errors such as the above

Details

Integrity check returns invalid values for SubmissionType in table StpSubmission.

Resolution:

Integrity check returns correct values for SubmissionType in table StpSubmission.

Lump Sum A not reported for employees re-hired post termination

Details

When an employee is paid out on termination, and then re-hired in a different capacity, the lump sum A payment on termination was not being reported to the ATO via Single Touch Payroll (STP)TP. This applies for example to an employee made redundant with a redundancy payout, who is then re-hired as a casual.



Resolution:

The payment on termination will be reported when reporting with the new Single Touch Payroll v4 format.

Working Holiday Makers with no TFN need to be reported with the tax rate of 'W'

Details

When a working holiday maker does not yet have a valid tax file number (TFN 000000000), the holiday maker was being reported to the ATO via Single Touch Payroll (STP) with a tax rate of '4' instead of the correct tax rate 'W'.

Resolution:

A working holiday maker's tax details will only be able to be saved if their tax rate is 'W'.

Existing working holiday makers with tax rate '4' will be changed to have tax rate 'W' on upgrade.

Leave loading and leave loading cash-out allowances could not be configured as 'Overtime'

Details

Leave loading taken and leave loading cash-out allowances could only be configured as 'Paid Leave'.

Resolution:

Leave loading taken and leave loading cash-out allowances can now be configured as either 'Paid Leave' or 'Overtime'. All allowances with the sub-type of 'Leave Loading taken' can then be choses as a loading allowance on the annual leave table. Likewise appropriate allowances of sub-type 'Leave loading cashed-out' can be used as Loading Cash-out allowances on the leave cash-out allowance.

STP v3 submissions receiving Product ID errors

Details

The product ID reported to the ATO will be unique to PayGlobal when STPv4 is enabled. However, the v4 product ID is showing up on STP v3 submissions. This is creating submission problems because the generic MYOB product ID is still expected.



Resolution:

The PayGlobal unique product ID will only be used for STPv4 submissions.

STP Manager tool crashed while sorting some columns

Details

Sorting on several columns in the STP Manager tool crashed the STP Manager tool.

Resolution:

Sorting behaves as expected.

WFM - Incorrect Postal Address Data coming from PGPRMISC063B report

Details

When exporting employee details for Australian employees to Workforce Management, using report PGPRMISC063B, the postal address details are repeated in multiple fields.

Resolution:

The report definition for PGPRMISC063B has been updated to ensure that the postal address details are correctly exported.

Issues Resolved - New Zealand

Converting Annual Leave table to Weeks results in Incorrect Rounding

Details

When an annual leave table is converted to weeks, via the Annual Leave table form, PayGlobal was incorrectly rounding annual leave balances to two decimal places rather than four decimal places.

Resolution:

PayGlobal now correctly rounds annual leave balances to four decimal places when converting the annual leave table to weeks.

MYOB actively manages the compatibility of MYOB PayGlobal with various environments.

The current minimum supported version is v5.2.0 -

Minimum Supported Environments

The minimum operating systems PayGlobal required is:

- Desktop Operating System Windows 8.1
- Server Operating System Windows Server 2012
- SQL Server 2012
- .NET Framework It is recommended that latest version of .NET Framework run time is installed.
- Transport Layer Security (TLS) TLS 1.2 is recommended but PayGlobal will fall back if the Operating System doesn't enable TLS1.2.
