## Enhancements-Fiji

This section describes Fiji-specific software enhancements in this release version.

Social Responsibility Tax and Environmental and Climate Adaptation Levy change from 01 April 2022

From the 1st of April 2022, the environmental and climate adaptation levy has been dropped and partially included in the social responsibility tax. The new rates and thresholds for the social responsibility tax are

Chargeable Income	Social Responsibility Tax Payable
270,001 - 300,000	18% of excess over \$270,000
300,001 - 350,000	5,400 + 19% of excess over \$300,000
350,001 - 400,000	14,900 + 20% of excess over \$350,000
400,001 - 450,000	24,900 + 21% of excess over \$400,000
450,001 - 500,000	35,400 + 22% of excess over \$450,000
500,001 - 1,000,000	46,400 + 23% of excess over \$500,000
1,000,000 +	161,400 + 24% of excess over \$1,000,000

Note: The relevant percentage for FNPF employee super contributions is now 6% - this was effective from 1 Jan 2022.



# **Issues Resolved**

This chapter describes issues resolved in this release version.

#### All Countries

Employee fields are read-only when adding new employees if Workforce management enabled

#### Details

When adding new employees for companies that had Workforce Management enabled, some employee fields would be set to read-only and the user would be unable to edit them.

#### Resolution:

The checks for Workforce Management enabled employees have been changed to ensure they behave correctly when adding new employee records and leaves the fields as editable.

# Supported versions and environments

Compatible environments continuously change based on the developments in manufacturers' environments that are outside the control of MYOB.

MYOB actively manages the compatibility of MYOB PayGlobal with various environments.

The following sections outline the supported versions of MYOB PayGlobal products and the minimum environments they need to run.

## Employee Self-Service (ESS)

The current minimum supported version is v5.2.0.

Self Service 3.x and 4.x series are **no longer** supported.

If you are using an unsupported version, please contact your account manager so that we can help you upgrade to a more recent, supported version.

## Minimum Supported Environments

The minimum operating systems PayGlobal required is:

- Desktop Operating System Windows 8.1
- Server Operating System Windows Server 2012
- SQL Server 2014 (SP3)

Note: Support for SQL Server 2012 is also still supported but this expires July 2022.

- .NET Framework It is recommended that latest version of .NET Framework run time is installed.
- Transport Layer Security (TLS) TLS 1.2 is recommended but PayGlobal will fall back if the Operating System doesn't enable TLS1.2.
