Introduction

Welcome to the 2017.1.12 release of MYOB Advanced.

What's New in this Release?

The 2017.1.12 release contains additional updates to the Advanced Payroll module for the new NZ financial year along with feature and licence updates to Advanced Business. This release also addresses issues identified in previous versions.

Installing this Release

The 2017.1.12 release is automatically deployed to all production accounts.

Note: An updated licence is required to enable configuration options for the new features. While accounts in our managed environment will have their licences updated automatically, a local installation must be updated manually by navigating to the Licence Maintenance (SM.20.15.10) form and clicking the Update Licence button.

New Features

NZ Tax Updates

This release includes compliance updates for the 2018-2019 New Zealand financial year, in addition to those introduced in the 2017.1.11 release.

ND Tax Code Taxation

Employees using the ND (No notification) tax rate are taxed at a flat rate of 45% for normal earnings. This rate is now also used for extra payments.

Updates to Protected Net Earnings

The IRD has issued new directions on how an employee's protected net earnings (PNE) should be treated in cases where they have multiple Deductions to which a protected earnings threshold applies.

While Child Support Deductions have a 60% PNE threshold, it is possible for an employee to have other Deductions for District Court attachment orders—these also have a PNE threshold, which can be 60% or more, depending on the conditions of each attachment order.

The IRD has specified that the deductions in an employee's pay should be ranked as follows:

- Child support
- Other attachment orders
- ACC Levy
- Student loan repayments, including normal repayments and Commissioner deductions (SLCIR)
- KiwiSaver employee contributions
- Other voluntary deductions, including student loan voluntary repayments (SLBOR)

The Payroll module now processes deductions in this order, which means that if the pay is not enough to cover all deductions that are subject to PNE before the threshold is reached, the deductions at the top of the list will be deducted in preference to those below.

Snapshot Management Updates

Enforcement of Snapshot Restriction

The 2017.1.11 release introduced a restriction on the number of snapshots a site may have. This restriction was noted but not enforced to begin with; as of this release, the restriction of **five snapshots per site** is enforced.

The number of snapshots a site can have is now controlled by an entitlement with a default value of five—this entitlement controls the number of snapshots that can be created across the whole site, not for a specific company. Once a site has reached their entitlement threshold, they will not be able to create any additional snapshots until they have cleared some snapshots and fallen below the threshold.

Note: The snapshot entitlement and current number of snapshots is displayed on the Companies form (SM.20.35.30).


Should a site require more than five snapshots, you can request an increase in the entitlement level by logging a request in Archie, providing a business case to support the increase.

Update to Snapshot Roles


The "Lockout Manager" and "Snapshot User" roles can now be assigned to users with the "People Business User" licence type. This allows sites that use Advanced People in standalone mode to schedule lockout periods and manage snapshots.

Reminders

This release adds the ability to add reminders to tasks and events. Add a reminder on the Tasks (CR.30.60.20) and Events (CR.30.60.30) screens by ticking the **Reminder** box and entering a date and time for the reminder:



At the specified time, the reminder will appear to all affected users:



For a task, the reminder appears to the user who created the task; for an event, the reminder appears to all users who were added to the event's Attendees tab.

Note: Users must be associated with an employee record for reminders to appear.

The Reminder window gives options to defer the reminder for a selected amount of time, to dismiss one or all reminders and to view the details of the selected reminder—clicking **View Details** or clicking directly on a reminder opens the associated task or event in a pop-up window.

Once a reminder's **Remind at** time and date has been reached, it appears every time the user navigates to a new screen. Users can also view their reminders by clicking the button in the Info area at the top right of all screens.
